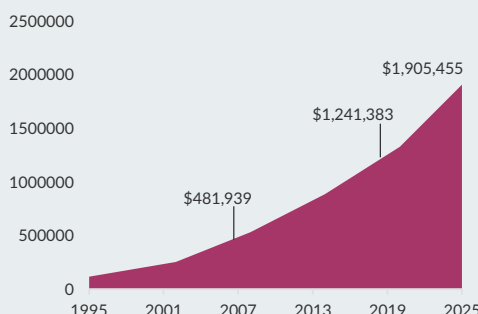

Growth of \$100,000 invested at start date 31 years ended October 31, 2025

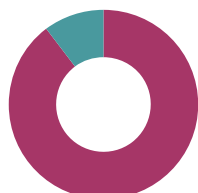

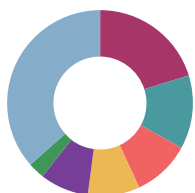
